## **Transition Factor for Eligible Hospitals for Medicare Incentives**

The transition factor phases down the incentive payments over the four-year period. The Final Rule states that the applicable transition factor equals one for the first payment year, three-fourths for the second payment year, one half for the third payment year, one-fourth for the fourth payment year, and zero thereafter.

## Stage of Meaningful Use Criteria by First Payment Year

- Data collection for attestation must occur in a continuous 90-day period in a federal fiscal quarter.
- The last quarter to begin data collection for Stage 2 is July 1st, 2014.

- Data collection for attestation must occur in a continuous 90-day period.
- However, you must complete your attestation no later than June 30th, 2014.
- \*\*\*Data collection for attestation periods and Meaningful Use requirements are yet TBD. These are subject to change based on the anticipated 2017 Meaningful Use ruling.

## 2014 Changes

- EHRs Meeting ONC 2014 Standards starting in 2014, all EHR Incentive Programs participants <u>must adopt certified EHR</u> <u>technology</u> that meets ONC's Standards & Certification Criteria 2014 Final Rule.
- Reporting Period Reduced to Three Months to <u>allow providers time</u> to adopt 2014 certified EHR technology and prepare for Stage 2, <u>all participants</u> will have a three-month reporting period in 2014.
