PRIVATE DUTY

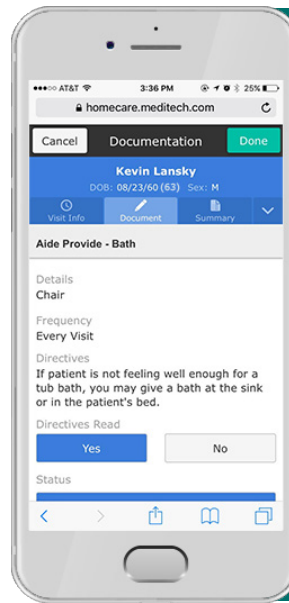
For agencies that accept patients using private insurance, add our Private Duty solution designed to bypass unnecessary regulatory requirements.
